We use your Personal Information only for providing our firm's services and improving the Sites. By using the Sites, you agree to the collection and use of information in accordance with this policy.

Information Collection and Use

While using our Sites, we may ask you to provide us with certain personally identifiable information that can be used to contact or identify you. Personally identifiable information may include, but is not limited to, your name and/or email address and other similar contact information ("Personal Information"). We do not share any of the information you provide with others unless we say so in this Privacy Policy, or when we believe in good faith that the law requires it. Log Data

We do not sell, rent, or lease information about you. We will not disclose Personnel Information or message data to third parties without your consent, except to the extent explained in this Privacy Policy.

SMS/Text Messaging
